SYNOPSIS

On October 25, 2006, this investigator received a response letter from BLANCO'S attorney, Howard Hochman, which basically states that "...it appears that the July 16, 2006, memo from Jan Benjemann to Representative Julio Robaina bares the greatest factual relationship to the allegations of the complaint. Hochman also averts to not being able to properly respond to certain allegations, such as "vendor bills", maintenance cost and BLANCO using her own "people" to infiltrate the board of some of the associations, without the proper documents and names of said individuals..." {Exhibit 5}

On October 27, 2006, this investigator received a written request from attorney Howard Hochman for additional information that his client:

- Took over various boards with her own people;
- Improperly billed associations by either inflating or arbitrarily billing for unnecessary services; and
