Dear Ms. Ellington:

The Department of Economic Opportunity (Department) has completed its review of the Proposed Revived Declaration (Declaration) and other governing documents for the Myakka Valley Ranches Improvement Association, Inc. – Unit III (Association), and has determined that the documents fail to comply with the requirements of Chapter 720, Part III, Florida Statutes. Therefore, the proposed revitalization of the Association's Declaration and other governing documents is denied.

The reasons for the denial are:

- 1. Section 720.405(1), Florida Statutes, requires the proposal to revive a declaration of covenants and an association for a community to be initiated by an organizing committee consisting of not less than three parcel owners located in the community that is proposed to be governed by the revived declaration. The name, address, and telephone number of each member of the organizing committee must be included in any notice or other document provided by the committee to parcel owners to be affected by the proposed revived declaration. The July 5, 2022 letter provided by the organizing committee to the affected parcel owners did not include the address and telephone number of each member of the organizing committee. The April 8, 2022 notice provided by the organizing committee to the affected parcel owners did not include the name, address, and telephone number of each member of the organizing committee.
- Section 720.405(1), Florida Statutes, requires the proposal to revive a declaration of
 covenants and an association for a community to be initiated by an organizing committee
 consisting of not less than three parcel owners located in the community that is proposed to
 be governed by the revived declaration. The organizing committee consisted of only two
 members from the Unit III community.
- 3. Section 720.406(1), Florida Statutes, requires the Association to submit its proposed revived declaration and other governing documents to the Department no later than 60 days after

the date the proposed revived declaration and other governing documents are approved by the affected parcel owners. The Association submitted its proposed revived declaration and other governing documents to the Department more than 60 days after it was approved by a majority of the affected parcel owners.
