

Extremely Urgent **Voter Protection Fraud Alert**

Dear Jan Bergemann,

It's possible you have been the victim of a deception or fraud.

This is an extremely important letter. Please take a few minutes to read every word carefully.

My name is John Thrasher. I am the former Speaker of the Florida House of Representatives. Your name recently appeared on a petition that you probably did not mean to sign.

It's a petition on a proposed Amendment to Florida's Constitution that has to do with how Florida's land is used – an amendment that will lead to higher property taxes for you.

This proposed Constitutional Amendment was created by land-use lawyers and special interests for their benefit at the expense of the citizens of Florida.

Many who signed this petition have little idea what they signed. They were approached in a shopping center parking lot while carrying groceries or while busy with something else.

You might not even be aware you signed this petition. It's very possible you did not sign it. All we know is that your name appears on the official list as a signer.

Deceptive tactics were used to get people to sign this petition. If you signed this petition in error or never signed it at all, under Florida law, you have up to 150 days from the day you sign a petition like this to revoke your signature.

I have enclosed an official government PETITION REVOCATION FORM that allows you to revoke your signature. To revoke your signature from this petition, please just:

- 1) Fill out this form.
- 2) Sign it and date it.
- 3) Use the enclosed pre-addressed stamped envelope to mail your completed PETITION REVOCATION FORM to my office.

Here's what's happening.

Paid petition gatherers, many from out of state, have been hired to convince people to sign this disastrous Amendment. The tactics of many paid gatherers have been documented in official court filings to be deceptive and fraudulent.

Currently, the Florida Supreme Court has ordered the investigation of identity theft and petition fraud that includes forging voter signatures, lying about the affect of another proposed amendment, signing the name of dead persons on the petition, and copying the voter name and signature onto multiple petitions.

Many voters do not recall ever signing THIS Amendment, yet their name appears on the official list. Others were not told the truth about the affect of this bad Amendment.

Unfortunately, thousands of good Floridians are potentially being tricked into signing this proposed Amendment to Florida's Constitution that:

- will be a bonanza for certain select special interests (many of them big developers from out of state who have no concern for Florida); and
- will likely result in huge property tax increases for the citizens of Florida.

These special interests are hoping they can sneak this Amendment into Florida's Constitution before you fully understand what it would do.

Their lawyers and lobbyists have done an expert job of crafting this proposed Constitutional Amendment to make it sound like it's about protecting Florida's scenic beauty and natural resources – when it will actually do exactly the opposite.

Now, here's another key point to keep in mind.

If you fill out the enclosed PETITION REVOCATION FORM (to take your signature back) you are always free to support this proposed Constitutional Amendment later – after you have had a chance to study it.

But if you do not take your signature back now, your signature cannot be revoked later.

That's because there is a deadline for revoking your signature.

Once 150 days passes, your signature on their petition is permanent, and can never be removed.

We are quickly coming up on the 150-day deadline for you to be able to revoke your signature.

So it's essential for you to act on this today.

Filling out and signing this PETITION REVOCATION FORM and mailing it back allows you the freedom (the option) of supporting their Constitutional Amendment later if you decide that's what you want to do.

But I doubt most Floridians will want this Amendment to Florida's Constitution – not once they fully understand what will happen to our great state if this Amendment passes.

If you just glance quickly at this proposed Constitutional Amendment, you might be deceived into thinking this is an Amendment about protecting Florida's scenic beauty.

But this Amendment will do the exact opposite of that.

This Amendment would allow big developers and special interests (many from out of state) to plunder and profit from destroying Florida's scenic beauty. And you will pay their bills in the form of

higher property taxes.

If you read their proposed Constitutional Amendment carefully (it's reprinted on your PETITION REVOCATION FORM) you will notice that it shifts power over the use of Florida's public land to certain "electors."

By making this dramatic change, lobbyists and big developers will have the power to use Florida's public lands as they please at your expense. And Florida's taxpayers (you) will pay their bills through higher property taxes.

Unless you want higher property taxes and Florida's scenic beauty destroyed by big developers, you will certainly want to revoke your signature from their petition.

You can do that simply by filling out this PETITION REVOCATION FORM.


Remember, filling out this PETITION REVOCATION FORM commits you to nothing.
